What is the census date?

Census dates for each unit of study are predetermined, and the student will not incur VET Student Loan liability until <u>AFTER</u> each census date. SWTAFE census dates are specific, as shown in the information table below. The census date of a unit of study (which forms part of an eligible course of study) is the last day a student can submit their request for VET Student Loan assistance through the Department of Employment and Workplace Relations (DEWR) eCAF Portal.

Students who have elected not to access a VET Student Loan will be required to pay fees in full by this date. If you have not submitted a completed Request for a VET Student Loan on or before the census date, you WILL NOT be entitled to a VET Student Loan for that unit and will therefore be required to pay the fee. Students will be advised of the census dates that apply to them at the time of enrolment.

The Census Date is the last day you can:

- 1- Complete the eCAF application to access a VET Student Loan (VETSL)
- 2- Withdraw your enrolment <u>without</u> incurring the cost or debt for your course **NB: the census date can vary between individual courses**

Every part of a course (unit or subject) has its own census date, so a student will incur their debt as they progress through the course, not the entire course cost at the beginning. The following census dates apply to all units of study on SWTAFE's 2026 VET Student Loan Course Schedules.

Is there anything else I will have to do?

You will be required to demonstrate that you are progressing throughout your course.

You will receive emails from the Department of Employment and Workplace Relations (DEWR) with instructions to log in online and acknowledge that you accept the loan you will receive for the course.

What happens if I withdraw on or before the census date?

If you correctly withdraw from any unit on or before the census date, you will not incur a debt for that part of your course. If you have already made an upfront payment of your tuition fees, you will receive a refund from South West TAFE.

What happens if I withdraw after the census date?

If you fail the unit or withdraw incorrectly after the census date, you will incur a FEE HELP debt to the Australian Government.

If, after the census date, special circumstances occur and you are unable to continue your studies, you can apply to have your VET Student Loan debt removed for that unit(s).

Time limits apply for you to have your FEE- HELP balance re-credited due to special circumstances Please refer to *PPP153 VET Student Loan Review Guidelines* for further information.
